Did not have to show as a 3 year old. Entry fee is \$400.00 per head. DUE OCT. 19, 2021; After OCT. 19, NO REFUNDS. Heading and Heeling may show in both. Head horses will be judged on ability to score-run-rate-handle cattle in the corner-face. Heel horses will be judged on ability to score-run-rate in the corner-stop. Standard AQHA equipment rules apply as well as general rules of behavior and abuse. 10 entries or less: 2 rounds. 11 or more entries: 2 rounds and Short-Go. 20% of entries no less than 5. All monies paid on total score. 2 Judge system: 1 human & 1 time. Score 60-80 time is deducted from 80. Headers and Heeler will show from behind electric eye barrier. Bring your own help. Abusive behavior to horse or cattle will not be tolerated.
